- f. Commissioner Reports- Commissioner Keim wished everyone a Healthy New Year. Commissioner Hines had a question on the new street signs, she suggested that the new signs should be cemented in because they are moveable by hand and was worried that in a hurricane they can come down. Mayor Comerford stated they are cemented, and it takes about 2 weeks to harden.

h. Mayor Comerford- With everyone's permission wanted to add a Proclamation honoring the 50th Anniversary of the Historical Society as to the Lighthouse to the end of the meeting. There was no objection from the Commissioners. Mayor Comerford also announced the cancellation of the annual party to be held on the 14th of January. They are hoping to still have a live meeting on January 31st which will be the State of the Colony Address and the Social Committee announces its agenda for the year and they introduce the three candidates, Commissioner Keim, Marie Rosner and Dr. Stephen Pollard. If the meeting cannot be done live, then they will do it via Zoom. The South County Fair is on and the Mayors Parade will be held on January 16 at 1:00pm.

4. Vote: First Reading: Ordinance 2022-01

AN ORDINANCE OF THE TOWN COMMISSION OF THE TOWN OF JUPITER INLET COLONY, FLORIDA AMDENDING CHAPTER 4. BUILDINGS AND BUILDING REGUALTIONS, ARTICLE I IN GENERAL OF ITS CODE OF ORDINANCES BY CREATING A NEW SECGTION 4-16 STORM PANELS, HURRICANE SHUTTERS IN ORDER TO REGULATE THE DATES OF PERMISSIBLE INSTALLATION OF SUCH STORM PANELS OR HURRICANE SHUTTERS; PROVIDING FOR THE ISSUANCE OF A PERMIT AND PERMIT FEE FOR EXTEDNDED DATES OF INSTALLATION OF STORM PANELS OR HURRICANE SHUTTERS; PROVIDING A CONFLICTS CLAUSE, A SEVERABILITY CLAUSE AND AN EFFECTIVE DATE; AND FOR OTHER PURPOSES.

Mr. Doney explained briefly that the ordinance would prohibit anyone from having their hurricane shutters up between December 1st and June 1st, except if there is an event outside of the time frame, a named storm and Palm Beach County is within the cone of probability. There is an exception to where the dates can be extended to no earlier than May 21st and no later than December 10th and there would be an application procedure. If someone has shutters up now, they would have 30 days to remove them upon adoption of the ordinance.

Commissioner Hines made a motion to approve the Ordinance. Commissioner Block seconded the motion. Motion passed 5-0.

5. Proclamation:

Mayor Comerford and Vice Mayor Block received an email from Jamie Stuve, the longtime Executive Director of the Loxahatchee River Historical Society inviting everyone to an event that would be held on January 27th, which is the official 50th Anniversary of their founding. Mayor Comerford accepted the invitation on behalf of the Commissioners. Mayor Comerford stated that it would be appropriate if he attended with a Proclamation in hand. The proclamation will compliment Jaime Stuve for her leadership and honor the Historical Society.

Mayor Comerford asked for the approval to sign on behalf of the Commissioners.

Commissioner Block made the motion to approve the Proclamation. Commissioner Hines seconded the motion. Motion passed 5-0.
